TENNIS AND PICKLEBALL COURT PAINTING MCGUIRE PARK

PAINTING OF ONE TENNIS COURT AND FOUR PICKLEBALL COURTS

SUMMER 2018

1.0 INTRODUCTION

The Town of Penetanguishene requires the services of a contractor to paint one tennis court and four pickleball courts in McGuire Park. The painting will take place on new asphalt following court reconstruction.

Only contractors with a minimum of 5 years experience in providing related services will be eligible for this project. All prospective bidders are required to submit a listing of at least three (3) projects, including references, completed in the last five (5) years where they have successfully completed similar work.

2.0 SCOPE OF SERVICES

The selected vendor will be responsible for providing the following services as part of their overall work plan:

- 2.1 Provide all labour, materials, equipment, and supervision for the painting of new asphalt at McGuire Park (attached as appendix B with location map included).
- 2.2 The selected contractor will apply a minimum of 2 coats of acrylic resurfacer and 2 coats of colour. The courts must be painted in two colours with white lines defining the courts and playing areas.

- **2.3** The total surface area requiring painting is 109 feet x 120 feet.
- 2.4 The selected supplier will be required to provide a warranty period of not less than one (1) year.
- 2.5 Prior to the start of work the selected contractor shall submit to the Town proof of WSIB clearance and general liability insurance coverage not less than \$2 million naming "The Corporation of The Town of Penetanguishene" as an additional insured.
- **2.6** The lowest or any quotation not necessarily accepted.

4.0 SUBMISSION

- **4.2** Submission must be valid for a minimum of 90 days from the date of the closing of the RFQ.
